

RESOLUTION NO. G-19-14

BAC Resolution Declaring S/LCRB and Recommending Approval

WHEREAS, the Philippine Council for Agriculture, Aquatic and Natural Resources Research and Development (PCAARRD) advertised the Invitation to Bid of the project **"Supply and Delivery of Office Furniture, Device, Supplies, Prepaid Cards, and Building and Utility Supplies"** with an Approved Budget for the Contract (ABC) amounting to **FOUR HUNDRED SIXTY EIGHT THOUSAND EIGHT HUNDRED EIGHTY SIX PESOS & 50/100 (PhP468,886.50)** at the PCAARRD Website, Philippine Government Electronic Procurement System (PhilGEPS) and conspicuous places in the Municipality of Los Baños from April 26 to May 20, 2019;

WHEREAS, in response to the advertisement, two prospective bidders namely: SMS Marketing and Central Book Store, Inc. participated in the pre-bid conference on May 6, 2019;

WHEREAS, bidding proposals from three bidders, namely: Pinnacle Sphere Enterprises, Silver Pulp Trading, and SMS Marketing were received for the opening of bids on May 20, 2019;

WHEREAS, Pinnacle Sphere Enterprises was found to be non-complying since completion date of the project indicated on their submitted Single Largest Completed Contract (SLCC) is beyond the required twelve (12) months coverage; thus, leading to its disqualification;


WHEREAS, Silver Pulp Trading and SMS Marketing were found to be eligible with financial proposals as follows:

WHEREAS, upon post-qualification of the Technical Working Group (TWG) for Supplies and Materials, Silver Pulp Trading as the bidder with the lowest calculated bid for Lot C and F, and SMS Marketing as the bidder with the single calculated bid for Lot A, B, and G, and lowest calculated bid for Lot D and E were found to have complied with and responsive to all the requirements and conditions in the bidding documents;

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to declare **Silver Pulp Trading** as the bidder with the lowest calculated responsive bid for Lot C and F in the amount of **ONE HUNDRED SEVENTY NINE THOUSAND SEVEN HUNDRED EIGHTY FIVE PESOS & 50/100 (PhP179,785.50)** and **SMS Marketing** as the bidder with the single calculated responsive bid for Lot A, B, and G, and lowest calculated responsive bid for Lot D and E in the amount of **TWO HUNDRED TWO THOUSAND THREE HUNDRED NINETY SIX PESOS & 50/100 (PhP202,396.50)** and to recommend to the Executive Director of PCAARRD the award of contract at its respective bid price.






