CONTRACT AGREEMENT


This AGREEMENT, made this JAN 26 2017 day of _____, 2016 between **PHILIPPINE COUNCIL FOR AGRICULTURE, AQUATIC AND NATURAL RESOURCES RESEARCH AND DEVELOPMENT (PCAARRD)**(hereinafter called the "Entity") and **TELESIGHT COMPUTER AND SURVEILLANCE SYSTEM**(hereinafter called the "Contractor")




