

CONTRACT AGREEMENT

This AGREEMENT, made this _____ day of _____, 2016 between **PHILIPPINE COUNCIL FOR AGRICULTURE, AQUATIC AND NATURAL RESOURCES RESEARCH AND DEVELOPMENT (PCAARRD)**(hereinafter called the "Entity") and **TELESIGHT COMPUTER AND SURVEILLANCE SYSTEM**(hereinafter called the "Contractor")

Other contract documents that may be required by existing laws and/or the Entity such as the construction schedule and S-curve, manpower schedule, construction methods, equipment utilization schedule, construction safety and health program approved by the DOLE, and PERT/CPM or other acceptable tools of project scheduling for infrastructure projects.
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.

The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.






