

### CONTRACT AGREEMENT

THIS AGREEMENT, made this 10th day of January 2019 between The **Philippine Council for Agriculture, Aquatic and Natural Resources Research and Development (PCAARRD)**, a government agency with principal office at Los Baños, Laguna (hereinafter called the "**Entity**") and **Systematic Pest Control**, a pest control entity duly organized and existing under and by virtue of the laws of the Philippines with office address at Km 65 National Road, Purok 5, Brgy. Maahas, Los Baños, Laguna (hereinafter called the "**Contractor**").

WHEREAS, the Entity is desirous that the Contractor execute the "**Non-Structural Pest Control Service for CY 2019**" (hereinafter called the "Works") and the Entity has accepted the Bid for **SEVENTY FIVE THOUSAND PESOS (P75,000.00)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
  - a) Invitation to Bid for Small Value Procurement;
  - b) Technical specification of the required service;
  - c) Winning bidder's financial proposal;
  - d) Notice of Award;
- 3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
- 4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
