KNOW ALL MEN BY THESE PRESENTS:

This Agreement made, this ____ day of 2017, between

PHILIPPINE COUNCIL FOR AGRICULTURE, AQUATIC AND NATURAL RESOURCES RESEARCH AND DEVELOPMENT (PCAARRD), a government agency under the laws of the Republic of the Philippines with principal address at Paseo de Valmayor, Brgy. Timugan, Los Baños, Laguna represented herein by its Acting Executive Director, Reynaldo V. Eborá, hereinafter referred to as the "**Procuring Entity**"

and

PLDT Inc. (formerly PHILIPPINE LONG DISTANCE TELEPHONE COMPANY), a corporation duly organized and existing under the laws of the Republic of the Philippines with principal office address at Ramon Cojuanco Building, Makati Venue, Makati City, represented herein by its Sector Head, Corporate Relationship Management F, Benedicto T. Perez, hereinafter referred to as the "**SUPPLIER**".




