



BAC Resolution Declaring LCRB and Recommending Approval

**WHEREAS**, the Philippine Council for Agriculture, Aquatic and Natural Resources Research and Development (PCAARRD) advertised the Invitation to Bid on the project "Supply and Delivery of Q1 CY2025 Office Supplies (EPA)" (IB Nos. 24-09-20a-EPA and 24-09-20b-EPA) with an Approved Budget for the Contract (ABC) amounting to ONE MILLION NINE HUNDRED NINETY-NINE THOUSAND NINE HUNDRED NINETY-FIVE PESOS AND 90/100 (PhP1,999,995.90) at the PCAARRD Website, Philippine Government Electronic Procurement System (PhilGEPS) and conspicuous places in the Municipality of Los Baños from September 26 – October 16, 2024;

**WHEREAS**, four (4) prospective bidders namely: 1) Lambert Trading, 2) JMO Consumer Goods Trading, 3) SMS Marketing, and 4) MCSA Marketing participated in the pre-bid conference on October 4, 2024;

**WHEREAS**, bid proposals from five (5) bidders, namely: 1) J.M.O. Consumer Goods Trading, 2) Lambert Trading, 3) MCSA Marketing, 4) Reneo Trading, and 5) SMS Marketing were received for the opening of bids on October 16, 2024;

**WHEREAS**, all five (5) bidders were declared eligible with financial proposals as follows:


