CURRENT APPROPRIATIONS

The Council's accomplishments during the first quarter of 2021 are as follows as per DBM-prescribed performance indicators:

Outcome Indicators

Percentage of priorities in the Harmonized National R&D Agenda (HNRDA) addressed

As of Q1, 85% or 41 out of the 48 HNRDA priorities were addressed by PCAARRD's supported and monitored programs/ projects. Total accomplishments reported is 5% higher than the quarter target of 80% (38/48). Compared to the annual target, this is equivalent to 94% (85%/90%) accomplishment rate. This was realized since some projects have addressed not just one but multiple priority areas.

Number of partnerships with public and private stakeholders and international organizations

In Q1, the reported accomplishments on partnerships is 21% higher than the quarter target (157/130). On an annual basis, this registered an accomplishment rate of 112% (157/140). This was due to more than one institution involved in implementing specific PCAARRD-funded programs/projects.

Output Indicators

Number of projects funded

Q1 accomplishments exceeded the quarter target by 88% (239/127). This is because some projects approved in Q4 2021 were provided funds during this quarter period subject to compliance of implementing agencies to documentary requirements for fund release. Compared to annual target, this is equivalent to 36% accomplishment rate (239/663).

Number of projects monitored

The quarterly accomplishments exceeded the target set by 171% (550/203) due to the extension in time of ongoing projects and commencement of newly funded/ implemented projects which has successfully satisfied the requirements for fund release. On an annual basis, this is equivalent to 85% accomplishment rate (550/647).

Percentage of projects completed which are published in peer-reviewed journals, presented in national and/or international conferences, or with IP filed or approved

In Q1, only 30 out of 48 (63%) completed projects were reported utilized, mostly presented during national fora/conferences. Compared to the annual target, this registered a 69% accomplishment rate (63%/90%).
